

## INVITATION TO BID

Notice is hereby given that Public Utility District No. 1 of Skagit County (Skagit PUD) will receive sealed Bids for the **Skagit Country Club Pipeline Replacement Project**. Each bid shall be placed in a sealed envelope and shall be mailed or delivered to Skagit PUD's office, Attn: Catherine Price, Contract Coordinator, 1415 Freeway Drive, Mount Vernon, Washington 98273, to arrive no later than 10:00 AM, Wednesday, November 15, 2023. All complete bids will be opened and publicly read immediately following.

### **Skagit Country Club Pipeline Replacement Project**

Installation of approximately 11,600 linear feet of water distribution piping along Rainier Drive, Eagle Drive, Fairway Drive and Country Club Drive, in Skagit County, State of Washington, consisting of 8-inch, 6-inch and 4-inch diameter PVC C-909 and Ductile Iron piping including fittings, thrust blocks, service connections, fire hydrants, branch and mainline valves, establishment of private water service connections, pavement repair, temporary traffic controls, temporary erosion control, disinfection, pressure testing, appurtenances and incidentals, such as abandonment of existing valves in place, dewatering, and landscape and surface restoration in estimated quantities identified in the Bid Proposal and as shown on the plans.

The location of the proposed work is shown on the project plans.
